1.Introduction



The Crail Community Partnership, in support of Crail Community Council, is holding an open session to present its Action Programme to the people of Crail on Saturday 1 February at Crail Community Hall from 10am to 12.00.

The purpose of this session is to update progress on its Action Programme since the Local Place Plan for Crail was completed in December 2023, and to ask for community support in implementing the Action Programme.

This is the Community's opportunity to become involved in projects and initiatives for Crail which will be implemented in the future.

Your involvement in this process matters.

Like the Local Place Plan, the Action Programme also presents the opportunity to contribute to the creation and shaping of the planning policy which Fife Council will be producing to replace the existing FifePlan.

2. How has Crail already contributed to Fife Council's Policy?



In 2017 the Crail Community came together to, amongst other objectives, "seek acommunity mandate to shape planning policy and major development proposals for the good of the community." Over the following 2 years workshops and public sessions were held and survey documents assessed. The surveys conducted in the Spring of 2018 and 2019 made clear the Community aspirations. For example, affordable housing is identified as a priority as is the need for more/better shops and for road and footpath provision and improvements. The Charette document published in 2019 was the product of this research and community consultation process.

Following the publication of regulations and guidance by the Scottish Government, the Charette document was revised and updated and was the subject of further public consultation in October and November 2023. This resulted in the Crail Local Place Plan ("LPP") which was completed and submitted to Fife Council for registration.

3. Progress on the Community Aspirations







The Crail Community Partnership was formed in 2019 charged with delivering the Community aspirations. The Crail Community Hall was acquired in 2021 for the people of Crail. Since then it has undergone a series of improvements (for example the provision of a new boiler and a new kitchen) and recently has been the subject of initiatives to lower the building's carbon footprint. That work is ongoing. It currently hosts the Friday Community lunch, Pilates, Yoga, Badminton, Pickleball, Table Tennis, the Wine Club and the Folk Club and many other activities. It raises significant revenue as a wedding venue, which helps subsidise rental costs to local community users and groups.

In terms of Green Spaces, land has been acquired for the Community to create a 14.3 hectare rewilded nature reserve. Initial work for that project is now complete and thanks to Community input with planting we are seeing growth and an increase of bird and animal visitors. Land has also been acquired (and work undertaken) at Pinkerton Triangle, Bow Butts and West Braes for the creation of accessible green spaces for the Community.

Waste facilities have been improved with new solar powered bins and a glass recycling facility.

The 20 mph traffic restriction has now been formally adopted through Crail and new and refurbished business premises have opened.

These initiatives have been implemented using funding from Government, other charitable foundations and also, importantly, from crowd funding and contributions from the Crail Common Good Fund. These projects could not have been achieved without continuing Community support.

But we cannot stand still if we are to achieve the objectives set out in the LPP and to continue to identify and implement new projects. The Crail Community Partnership is committed to implement the Action Programme and in the longer term to continue to supplement it and to consult the Community on it. We need your support, voices and your ideas to do this.

4. Fife Council and "Place Matters"



This review coincides with Fife Council's call for sites and ideas to be submitted. so that these can be considered for inclusion in new Fife-wide planning policy. The statutory planning policy for Crail is currently contained in the Scotland-wide planning document (NPF4) and in the Fife Plan. The Fife Plan is coming to the end of its life and Fife Council has issued a general invitation for people and organisations to submit ideas and proposals for sites to be included in the new Fife Plan which will be called "the Fife Place Plan" (FPP).

This consultation exercise (called by Fife Council "Place Matters") is currently open for submissions and will close on 24 February 2025. The timetable for the new FPP provides for adoption in June 2028 and there will further consultation and reporting in the meantime.

The Crail Local Place Plan was registered in May 2024 and has now attained official status. The result of this is that Fife Council will take it into account in drafting the new FPP. That is a significant success for us but there is an opportunity now to look again at the issues addressed in the LPP to see if there is more that we can say about our ideas and proposals for Crail. Following the public consultation exercise for the Action Programme, Crail Community Partnership will be reviewing it to see if any proposals lend themselves to submission to Fife Council for the Place Matters exercise.

Consultation

This Crail Action Programme was the subject of a four week consultation period in January and February 2025, including an open session at Crail Community Hall for the public to ask questions and air their views. Feedback responses show overwhelming support for the Action Programme. Comments received indicated priorities and delivery issues which Crail Community Partnership will take on board as part of its implementation of the Action Programme. A very slight amendment to the consultation version of the Action Programme has been made at point 12 ("affordable homes and hospitality workers") to clarify this issue.

Crail Community Partnership is grateful to all who responded to this consultation which enables the projects in the Action Programme to move to the next stage - implementation. Some of these initiatives will be the subject of submissions to Fife Council for its Place Matters consultation.

5. Why we need your support

With your support and suggestions this Action Programme will carry the endorsement of the Crail Community. We need your involvement to give that submission the weight it deserves. In the event that the Action Programme produces proposals which are capable of being submitted as part of the Place Matters submissions, your support will be essential to demonstrate Community buy-in to those submissions.
